Animal Shelter -- 609-265-5073

This is a place where county residents can take stray and unwanted animals and a line of defense against the spread of rabies by removing unwanted and stray animals from local communities. If your animal is lost, please call the shelter and inquire if the animal has been brought in.

Bioterrorism and Preparedness - 609-265-5548

Burlington County is susceptible to natural disasters such as hurricanes, severe thunderstorms, tornadoes, flood/ flash floods, winter storms, earthquakes, and forest fires, in addition to man-made disasters. One of our most important responsibilities is the ability to react immediately to any event that may threaten public health; more importantly, however, is our level of preparedness before that event occurs. Visit the Health Department website for downloadable family preparedness plans and other useful information.

Communicable Disease Program - 609-265-5533

This program provides screening and testing clinics for communicable diseases. It also offers immunizations to eligible children and adults. It also offers the following disease services: HIV/AIDS; Sexually Transmitted Diseases; Tuberculosis; Communicable Disease Control; childhood diseases; Influenza/Pneumonia immunizations; International Immunization Certificate Information; Rabies Control Program; West Nile Virus Control.

Community Nursing - 609-914-8550

This program provides health education/promotion programs and public health nursing services to Burlington County residents. Services include: prenatal, postpartum and newborn education & home visits to eligible county women and children; lead poisoning prevention and home visiting program; community outreach; communicable disease case management; case management services for special needs children, adult health screenings; and school age and adult immunizations.

Environmental and Consumer Health - 609-265-5515

This division protects us from contamination of our food and water, ensures safety where we live, work and play and obtains "Right to Know" data about the potential harm of products used in the community and work place. Inspections, investigation, environmental response and enforcement of environmental health regulations are keys to safeguarding the public's health.

Health Education - 609-265-5548

This program serves the educational needs of county residents and agencies. Resources have been collected and created to provide up-to-date information to individuals, businesses, schools, community groups, etc. Health promotion and educational materials are available free of charge. Staff is available to provide free community health education presentations and participate in health fairs and other community events.

Woman, Infant and Children (WIC) - 609-267-4304

WIC provides nutritional counseling and supplemental foods to pregnant, postpartum and nursing women and their children through age 5. Children are monitored to ensure proper growth and development. Eligibility is based on income and nutritional need. WIC clinics are located at multiple sites within the county.

The Department of Human Services consists of a wealth of services to support individuals in the community from all backgrounds, with various needs. We strive to provide one-stop human service shopping, a building in which all county residents find a wealth of resources working together to help them find their strength, resilience and direction into a brighter tomorrow.

Division on Aging – 609-265-5069

Aging Division provides Information and Assistance to seniors and caregivers on senior related issues. Outreach staff attends community events and provide presentations. Nutrition services are available, including Meals on Wheels and Congregate Nutrition sites. Funding is provided for various senior related services. Division of Behavioral Health 609-265-5536

The Division of Behavioral Health provides access to services for those dealing with or who have a loved one suffering from a disability, mental health needs, and/or alcoholism and drug abuse. Services, programs and referrals to partner agencies are available.

Division of Community Development 609-265-5072

This division carries out a wide range of activities directed toward revitalizing neighborhoods and providing improved community facilities and services giving maximum priority to low and moderate income persons.

First Time Homebuyers Program

The First Time Homebuyer Program provides direct financial assistance to low/moderate income persons to assist in the purchase of their first home by providing a zero (0%) interest loan of up to \$9000 in closing costs and down payment assistance.

Home Improvement Loan Program

The Home Improvement Loan Program provides technical assistance to qualified homeowners and makes a zero (0%) interest property improvement loans of up to \$20,000 to correct substandard housing conditions and to eliminate health and safety hazards.

Heater Replace Program

The Heater Replacement Program provides financial assistance to low income Burlington County homeowners in participating townships to pay for the purchase and installation of a replacement heating system. Eligible applicants may receive a grant for up to \$5,000.

Emergency Home Repair

The Emergency Home Repair Program provides limited grants to eligible homeowners to make emergency repairs to their homes. Services are provided to eligible customers on an "every-other-year" basis.

HOME Developer Program

This program is designed to work in partnership with local nonprofit and/or for-profit developers to fund a wide range of activities that build, buy, and/or rehabilitate affordable housing for rent or home ownership.

Burlington County Coalition for the Homeless (BCCH)

BCCH is the lead organization comprised of social service providers from both public and private non-profit agencies providing services and housing opportunities for the homeless in the County. BCCH plans the county's Homeless Assistance Continuum of Care System and makes recommendations for the use of funds to support that system.

Division of Employment and Training Services (609) 518-3900

The Employment and Training Division provides a range of employment and training services in partnership with state and local agencies and organizations through the America's Job Center of Burlington County. The Burlington County American Job Center offers a variety of comprehensive services and programs at no cost designed to benefit job seekers, laid off workers, youth, individuals currently working, veterans, and people with disabilities. The Division is a primary partner in the County's newly formed Workforce Development Institute of Rowan College at Burlington County.

Division of Veterans and Military Service (609) 265-5008

The Burlington County Department of Military and Veteran's Services is totally dedicated to our military and veteran community. We work closely with all veteran organizations as well as the military bases to keep them informed of the most current information available from the U.S. Department of Veteran's Affairs as well as the New Jersey Department of Military and Veteran's Affairs. We provide information and assistance in filing claims for service connected disabilities, veteran's war time pensions, surviving spouse wartime pensions, dependent indemnity compensation, dependent benefits and numerous programs covering a broad spectrum veteran programs.

Division of Youth Services (609)-265-5308

We provide a broad spectrum of services to support the education, employment and judiciary needs of youth and young adults in our county. Over 2,000 consumers are served on an annual basis through our collaborative network of partners and providers. The Juvenile Justice Commission (JJC) and Department of Labor (DOL) provide funding for our programs.

Our Division manages both funding sources and today offers over 30 programs which were created through an open bid, Request-for-Proposal (RFP) process. The county welcomes businesses, agencies and community leaders to participate in our RFP process as they best understand the unique needs of the population we serve.

With JJC funding we create Prevention programs through Reentry services; 19 programs are offered in this area. DOL funds are used to help our target population (Out-of-School youth and young adults ages 16-24) with GED preparation, gain an industry recognized credential, as well as assist with work skills development and job placement; 14 program components must be met with DOL funds.

YOUTH SERVICES - 609-265-3788

Youth Police Academies – Academies run three consecutive Saturday mornings for children ages seven to twelve years of age. Kids see a canine demonstration, a tactical team and learn bike safety, fire safety, how to avoid abduction and much more.

Youth Equestrian Program - This program is for first time offenders and is designed to give youth an opportunity to develop their leadership and decision making skills to provide them with challenges that will enable them to grow and experience their full potential as young adults. This program uses horses and experiential learning activities to teach youth lessons about truthfulness, integrity, anger management and other related topics. The program runs for ten weeks.

Law Enforcement Explorer Program – Designed for males and females between the ages of fourteen and twenty, who are interested in pursuing a law enforcement career.

COMMUNITY SAFETY SERVICES - 609-265-3788

Project Lifesaver - Special radio transmission bracelets are provided to children with Autism and adults with Alzheimer's, dementia or other conditions that may cause them to wander and not get home safely on their own.

Persons at Risk Registry – This is a tool law enforcement officers can use to identify persons with Autism, Alzheimer's, mental disabilities or other conditions that may cause them to wander from their home and be unable to return safely to their home.

Gun Safety Locks – Free trigger locks will prevent your firearm from being accidentally discharged by a child or unauthorized person.

MedInfo Program – Comprehensive medical history forms are kept in the refrigerator with special decals to provide medical first responders with crucial information.

TRAFFIC SAFETY - 609-265-3788

Child Safety Seat Inspection – FREE service to Burlington County residents. Dedicated State Certified Technicians are available to inspect your child safety seat. We check all seats for unsafe seats and recalls. Before installing your child safety seat, please read your vehicle's owner manual & child safety seat instructions.

Defensive Driving Program – Free six-hour block of classroom instruction to educate drivers on road safety and reduce their auto insurance by at least 5% and/or 2 points off their driving record. The National Safety Council charges \$10 for the certificate.

Safety Materials – A brochure containing information for motorcycles, pocket bikes, ATV's, mopeds and scooters is available, in addition to information on NJ Child Restraint Law and teen driving requirements.

Supervised Visitation: Provides professionally supervised visits between children and non-custodial parents. Families are Court referred. Court. Services include observation and monitoring by trained supervisors. Burlington County: 115 West Pearl Street, Burlington NJ 08016 - 609-394-5157

Parenting, Anger-Management and Healthy Marriage Classes: (classes and support groups offered in Spanish through El Centro)

Intensive Family Support Services-Burlington: The programs of Immigration Services help immigrants adapt to American customs and lifestyles. BIA-accredited case managers provide civil legal assistance that is recognized by the Department of Homeland Security. Programs are offered in Burlington, Mercer, Monmouth and Ocean Counties, and services are available in both English and Spanish. Programs are offered through Community Services (learn more about *Community Services* at "Housing and Food") and *El Centro*, a comprehensive resource center for Latino families in Trenton and adjacent communities.

Partial Care Program: Provides a wide range of psychiatric rehabilitation groups and activities for adults experiencing a mental illness who require a more intensive environment in order to reach their maximum potential for independent living. Programs are also available for adults experiencing a mental illness with substance abuse issues. Burlington, Mercer (Partners in Recovery) In Mercer, the Partial Care Program features an additional component that integrates primary healthcare services:

Outpatient Services: Provides ongoing follow-up psychiatric care and therapy for adults experiencing a mental illness, including substance abuse issues. Burlington, Mercer (Guidance Clinic)

Alcoholism/Addictions Outpatient Program: Provides individual, group, and family counseling for those with alcohol and substance use problems. Special DWI and Veterans programs. Services offered in Spanish and English.
